## **My Personal Statement:**

Simon Millson is the current Chair of CCMAC. Simon also Chairs the Masterplan Delivery Working Group, a joint committee between Lambeth Council and CCMAC charged with delivering some £1 million investment in Clapham Common.

Simon has had a home in Clapham since 1989. He strongly believes Clapham Common should be accessible to all, inclusive and safe. It should be treasured today and for future generations.

CCMAC aims are to maintain and implement a long-term strategy for the regeneration and improvement of the Common, with particular measures that address the climate and ecological emergencies; improve mental and physical wellbeing; and encourage people to socialise enhancing community spirit and social cohesion.

Collective achievements to date include refurbishment of the Bandstand, remodelled playground at Windmill Drive, new wildflower areas, new lighting, new bins, and a summer programme of music on the Bandstand. There are plans for more developments with a new waterplay, new benches and new wildflower meadows.

The bowling green pavilion and the derelict buildings besides Battersea Woods area also set for redevelopment in 2023.

If reappointed I am aim to work in partnership across CCMAC, member groups of CCMAC and Lambeth Council to manage Clapham Common as a valuable public asset and 'Site of Importance for Nature Conservation'; promote improvements on the Common with benefits to the local community and nature conservation; and to facilitate effective and sustainable management of the Common which is common land protected by legislation
