This includes monthly meetings of the whole Committee lasting no more than 2 hours; meetings every 1-2 months of working groups (each Committee member typically sits on one or two working groups); and email correspondence between meetings.

Members may also volunteer for activities on the Common, such as assisting with Bandstand concerts or litter picking.
